

General rental conditions

Booking

The booking can only be processed upon a deposit of 30% of the total amount of the stay. The booking becomes final as soon as it has been confirmed in writing by us. The reservation is nominative, meaning that it is forbidden to sublet or assign a third party. Any modification of the contract that may result in the variation of the amount of royalties in addition or in less must be signaled and will only be effective after agreement of the manager. In case of misstatement, the contract will automatically be terminated and the sums paid will remain acquired at the campsite.

Payment Methods

The full payment of your stay will be requested at your arrival. It is possible to pay by credit card or cash.

Cancellation

The 30% deposit required for the validation of your stay is non-refundable.

In case of cancellation more than 7 days before your arrival date the amount of the deposit paid will be credited to your customer account for a new stay during the year or Year +1. After this period this credit will be lost.

In case of cancellation within 7 days before your arrival date the deposit will be permanently lost

Prices

They include :

- the rental of accommodation
- supply of gas and electricity for the accommodation
- access to the swimming pool (reserved exclusively for the campsite's clients), playgrounds, sanitary, some activities...

They don't include :

- the tourist tax (this municipal tax is mandatory and is collected with the balance, at the current rate and during the reception period)
- supplements such as : animals, some activities, linen rental, various rental (barbecue..)
- Deposit for the rental is asked as a guarantee of the rental being CLEAN and in GOOD CONDITION (250€ that are given back at the departure after the check-out, subject to missing or deteriorated material)

Guarantees

A deposit of 250€ will be asked from you on the day of your arrival (per credit card or in cash. Maestro cards do not allowed for this transaction) in guarantee of a restitution of the accommodation in good condition and in perfect condition of cleanliness. A check of the accommodation is carried out before each arrival by the staff of the campsite. The day of your departure, we ask you to respect the instructions (clean the accommodation, defrost and clean the refrigerator, clean dishes and dried). A member of the staff will check the accommodation and the deposit will be refunded.

Noise and silence

- Guests are advised to avoid any noises and discussions that may be disturbing their neighbors.
- The sound devices must be adjusted accordingly. Closures of doors and car trunk should be as discreet as possible.
- Animals are accepted after the agreement of the management and are concerned by the payment of the daily fee. Their health record can be asked on the day of your arrival. Upon admission, owners of dogs and other animals must be able to present vaccination certificates. 1st category dogs "attack dogs" and 2nd category "guard and defense" dogs are forbidden.
- Dogs and other animals should never be left free. They must not be left at the campsite, even locked up in the absence of their masters who are civilly responsible.
- The silence must be total between 10 pm and 7 am.

Swimming pool

- The access to the swimming pool is only restricted for the residents of the campsite. Visitors are not allowed to access the pool.
- Before entering the pool, bathers must obligatorily pass under the shower and in the foot bath.
- The entrance to the pool is not allowed for unaccompanied children.

Others

- Only gas and electric barbecue are allowed.
- Traffic is limited to 10Km/h in the campsite. Traffic is prohibited at night from 10pm to 7 am.
